

Corpus of Law of PoH Origin Rationale

One uncertainty that may arise upon the approval of the PoH Origin Constitution relates to which PoH Legacy HIPs remain in force. Some HIPs might not be deemed compatible with the terms of the constitution, either due to their content or because they passed with a threshold lower than $\frac{2}{3}$ of the cast votes. Alternatively, all HIPs might be found inconsistent with the constitution due to having been passed without undergoing the constitutional check phase. To mitigate uncertainty and ensure a seamless transition to PoH Origin, the proposal for the Constitution encompasses the Corpus of Law of PoH Origin. The Corpus of Law is the list of PoH HIPs that will remain in force after the Constitution is approved. Hence, all HIPs that are not included in the Corpus are derogated from the moment this proposal is approved.

Corpus of Law Rationale

All PoH Legacy HIPs have been subject to a scrutiny test to determine if they should be part of the Corpus of Law. If a particular HIP receives a "no" in the questionnaire, we determine that it should not be included in the Corpus of Law.

Scrutiny Test Explanation:

1. **$\frac{2}{3}$ Threshold:** The first filter relates to the number of votes the HIP obtained. For the Corpus to be more legitimate in the new Constitutional era, the HIPs must have passed with a $\frac{2}{3}$ majority of cast votes. We are waiving the "constitutional check" requirement because otherwise, no legacy HIP would be in force.
2. **Is the HIP intended to govern future actions of the PoH Origin DAO?:** Some HIPs may have been intended to govern a specific matter or situation that no longer exists and do not intend to govern any future events of the DAO. These types of HIPs are irrelevant for the future, and there's no reason to include them in the Corpus.
3. **Is it compatible with the terms of the Constitution?:** In this phase, we analyze whether the HIP contradicts the Constitution's terms. There might be gray areas in this test. Some HIPs may be partially constitutional due to having some provisions that are compatible with the Constitution and some that are not. There might be rules addressing issues already regulated by the Constitution that are not necessarily incompatible but add an extra layer or requirements, especially regarding voting rules.
4. **Would it be reasonable to include this HIP in the Corpus of Law?:** This last test will be answered with "no" if the previous 3 tests fail, however if the previous tests are answered yes, this test mandates to analyze if there are other legitimate reasons not to include the HIP in the Corpus of Law. For example, some HIPs have passed with a $\frac{2}{3}$ of votes, but those votes are mainly represented by members who will not be part of PoH Origin, potentially reducing the legitimacy of that HIP to govern the future of PoH Origin. After the fork, PoH Origin supporters ceased participating in proposal votings, resulting in all HIPs following the fork having significantly low legitimacy. Consequently, these will not be included in the Corpus of Law.
